Fiscal Year 2023 Appropriations Bill At-A-Glance



Provides **\$90.9 billion, an increase of \$9.9 billion**, to create jobs, rebuild crumbling infrastructure, expand access to safe and affordable housing, and promote safety and resiliency

Creates Good-Paying Jobs and Rebuilds Critical Infrastructure

- Creates and sustains thousands of high-quality American jobs in construction and related industries
- Invests in airports, highways, transit, passenger rail, and port systems by providing \$105.4 billion in budgetary resources for the Department of Transportation
 - Fixes roads and highways, expands bicycle and pedestrian infrastructure, strengthens auto safety programs, and invests in the transit state of good repair, consistent with the historic investments in the Infrastructure Investment and Jobs Act
 - Increases discretionary investments in transit and passenger and freight rail by 23 percent and expands port infrastructure programs by nearly 30 percent

Grows Opportunity Through Affordable Housing

- Protects housing assistance for more than 4.8 million individuals and families
 - Provides \$31 billion for Tenant-based Rental Assistance to continue serving more than 2.3 million households nationwide, including \$1.1 billion to expand housing assistance to more than 140,000 low-income families, including survivors of domestic violence and veterans
 - o Invests an additional \$14.9 billion for Project-based Rental Assistance to continue to house more than 1.2 million very low- and low-income households nationwide
- Includes over \$12.8 billion for new affordable housing, critical health, safety, and maintenance improvements for public and low-income housing, and community development activities
 - o Funds the construction of approximately 5,600 new units for seniors and people with disabilities
 - Invests \$500 million to preserve and revitalize manufactured housing communities, home to over 20 million low-income and working families across America
 - Includes \$1.7 billion for states and local governments through the HOME Investment
 Partnerships Program and increases investments in distressed neighborhoods through the
 Choice Neighborhoods Initiative program
- Invests \$3.6 billion in efforts to reduce homelessness through Homeless Assistance Grants, including targeted services for survivors of domestic violence and youth experiencing homelessness

Promotes Safety and Resiliency

- Provides \$1.6 billion to ensure safe air travel and \$2 billion for vehicle and highway safety programs
- Includes \$415 million in Lead Hazard Control and Healthy Homes, including \$85 million for the Healthy Homes Initiative to address health and safety hazards in the home, such as carbon monoxide and mold
- Provides \$3.4 billion to address critical routine maintenance and repairs in nearly 1 million public housing units and an additional \$65 million to reduce health hazards in public housing
- Invests in resilient, clean, multimodal transportation, including \$305 million for new bicycle, pedestrian, and transit focused investments, \$75 million for low and no emission buses, and \$775 million for RAISE grants, while providing \$133 million in research to reduce the environmental impact of aviation
