Fiscal Year 2023 Appropriations Bill At-A-Glance



Provides **\$87.3 billion, an increase of \$6.3 billion**, to create jobs, rebuild crumbling infrastructure, expand access to safe and affordable housing, and promote safety and resiliency

Creates Better-Paying Jobs and Rebuilds Critical Infrastructure

- Creates and sustains thousands of high-quality American jobs in construction and related industries.
- Invests in airports, highways, transit, passenger rail, and port systems by providing \$106.3 billion in budgetary resources for the Department of Transportation.
- Fixes roads and highways, expands bicycle and pedestrian infrastructure, supports Federal auto safety programs, and invests in the transit state of good repair, consistent with the historic investments in the Infrastructure Investment and Jobs Act.

Grows Opportunity Through Affordable Housing

- Protects housing assistance for more than 4.8 million individuals and families:
 - Provides a combined \$45.2 billion for Section 8 Rental Assistance to continue serving more than 3.5 million households nationwide, including an expansion of housing assistance to more than 12,000 low-income families, survivors of domestic violence and veterans.
- Includes over \$12.6 billion for new affordable housing, critical health, safety, and maintenance improvements for public and low-income housing, and community development activities:
 - Funds the construction of nearly 2,800 new units for seniors and people with disabilities, including \$25 to support new housing units for intergenerational families.
 - Invests \$225 million for a new program to preserve and revitalize manufactured housing communities, home to over 20 million low-income and working families across America.
 - Includes \$1.5 billion for states and local governments through the HOME Investment Partnerships Program and increases investments in distressed neighborhoods through the Choice Neighborhoods Initiative program.
- Invests \$3.6 billion in efforts to reduce homelessness through Homeless Assistance Grants, including targeted services for survivors of domestic violence and youth experiencing homelessness and \$75 million to spur new construction of permanent supportive housing.

Promotes Safety and Resiliency

- Provides \$1.6 billion to ensure safe air travel and over \$2 billion for vehicle and highway safety programs.
- Includes \$410 million in Lead Hazard Control and Healthy Homes, including \$85 million for the Healthy Homes Initiative to address health and safety hazards in the home, such as carbon monoxide, fire safety, and mold.
- Provides \$3.2 billion to address critical routine maintenance and improve the quality and safety of public housing for 1.7 million residents.
- Invests in resilient, clean, multimodal transportation, including for new bicycle, pedestrian, and transit focused investments, including \$542 million for Transit Infrastructure Grants, to assist transit agencies in purchasing low and no emission buses, improving urban and rural ferry systems, and carrying out local projects and \$800 million for RAISE grants, of which at least \$20 million is guaranteed to assist areas of persistent poverty.
