

UKRAINE SECURITY SUPPLEMENTAL APPROPRIATIONS ACT, 2024

Title I – Department of Defense

Ukraine Security Assistance Initiative – \$13.78 billion to provide assistance, including training, equipment, weapons, logistics support, supplies and services, salaries and stipends, sustainment, and intelligence support to Ukraine's military. It also allows the Secretary of Defense to accept contributions from partner nations in support of Ukraine.

Replenishment of U.S. stocks – \$13.41 billion to replenish U.S. stocks of equipment sent to Ukraine through Presidential drawdown authority.

European Command Operations and Related Activities – \$20.5 billion for U.S. Armed Forces mission support, intelligence support, pay, equipment, and related activities.

Oversight – Provides \$8 million for the Inspector General, including the Special Inspector General for Operation Atlantic Resolve and requires an Inspector General to provide a briefing to the Committees on activities.

Title II – Department of Energy

Office of Science, Isotopes – \$98 million for investments in the development and domestic production of isotopes.

National Nuclear Security Administration – \$149 million to prepare for and respond to potential nuclear and radiological incidents in Ukraine.

Title III – Department of Health and Human Services

Department of Health and Human Services, Administration for Children and Families – \$481 million for resettlement and support services, such as emergency housing, English language classes, job training, and case management, and extends eligibility for certain benefits to be offered to Ukrainian arrivals and refugees in fiscal year 2024.

Title IV – Department of State and Related Agency

Economic Assistance – \$9.5 billion in forgivable loans for vital economic and budgetary support for Ukraine, including support for Ukraine's energy sector and other infrastructure needs and for assistance to other countries impacted by the situation in Ukraine.

Security Assistance – \$2 billion is security assistance to Ukraine and other allies. Provides \$7.8 billion in presidential authority to transfer defense equipment to Ukraine.

State Department and USAID Operations – \$99 million for the State Department and USAID to respond to the situation in Ukraine and an additional \$18 million for the Inspectors General of the State Department and USAID to conduct oversight of Ukraine response activities.

Title V – General Provisions

Department of Defense Reporting Requirements – The Secretary of Defense, in coordination with the Secretary of State, is required to report to various Congressional Committees on measures taken to account for U.S. defense articles designated for Ukraine since the Russian invasion. Special emphasis must be placed on articles that require enhanced end-use monitoring to ensure that such articles reach their intended recipients and are used for their intended purposes. Finally, this report must include a description of any occurrences of articles that did not reach their intended recipients or were not used for their intended purposes and a description of any remedies taken.

The bill also requires the Secretary of Defense, in coordination with the Secretary of State to report to various Congressional Committees a description of U.S. security assistance provided to Ukraine since the Russian invasion that includes a comprehensive list of the defense articles and services provided and the authority and funding used to provide it.

State Department Reporting Requirements – Requires a detailed plan to describe how the resources provided for all assistance activities will be used. In addition, the bill requires a strategy on U.S. support for Ukraine against Russian aggression and a certification that mechanisms for oversight and monitoring are in place.

This title also includes technical budgetary provisions.
