1/ The National Institute for Food and Agriculture (formerly Cooperative State Research, Education, and Extension Service) is nearly \$82 million (which is 7%) over the Administrations budget request, including increases in key programs such as Hatch Act, Evans-Allen, the new competitive Agriculture and Food Research Initiative, Smith Lever, the 1890 programs, and the Veterinary Medical Services Act.

2/ The bill rejects \$267 million in proposed cuts to valuable farm bill conservation programs, including the Wetlands Reserve Program (\$184 million), Wildlife Habitat Incentives Program (\$43 million), Farm and Ranch Lands Protection Program (\$30 million), Healthy Forests Reserve Program (\$5 million), and Agricultural Management Assistance Program (\$5 million). In addition, the bill restores funding for the Watershed and Flood Prevention Operations Program and the Resources Conservation and Development Program, two programs eliminated in the budget.

3/ The bill includes increases for the departmental administration and offices of \$69 million for rent costs, \$44 million for IT security initiatives, \$27 million for office consolidation costs, and \$13 million for stabilization and reconstruction activities in Afghanistan and Iraq.
