SUMMARY OF FISCAL YEAR 2026 BILL

Financial Services and General Government

The fiscal year 2026 Financial Services and General Government funding bill includes \$26.3 billion, an increase of \$17.9 billion above the request and \$3.1 billion above the House level.

- **Provides critical financial products and services to low-income and underserved communities** by rejecting cuts and eliminations to the Community Development Financial Institutions program.
- **Makes our elections more secure** by increasing funding for the Election Assistance Commission's Election Security Grants.
- **Protects Grant Programs for Small Business** by rejecting cuts and eliminations to the Small Business Administration and includes stronger language to specify individual grant levels in law.
- **Respects the District of Columbia** by including language that automatically lets the District use local funding under a continuing resolution and doesn't include any new riders limiting the District's home rule.

Bill Summary

Department of the Treasury – For fiscal year 2026, the bill provides a total of \$13.1 billion for the Department, \$1.8 billion above the House level. Of the total provided, the bill includes:

- \$324 million for **Community Development Financial Institutions**, \$191 million above the budget request and the same as fiscal year 2025.
- \$185 million for the **Financial Crimes Enforcement Network**, \$5 million above the House level.
- \$238 million for the **Office of Terrorism and Financial Intelligence**, \$11 million above fiscal year 2025 and the same as the request.

- \$59 million for the **Cybersecurity Enhancement Account**, \$23 million above fiscal year 2025.
- **Internal Revenue Service (IRS)** – The bill includes \$11.2 billion for the IRS, \$1.4 billion above the request and \$1.7 billion above the House level. The bill includes expanded transfer authority for IRS to use existing balances. Including:
 - \$5 billion, \$1.4 billion above the request and \$2 billion above the House level for **Enforcement**.
 - \$3 billion, \$256 million above fiscal year 2025 and the House level, for **Taxpayer Services**.
 - \$3.2 billion, \$563 million above the request for **Operations Support**.

Executive Office of the President – The bill includes a total of \$873 million, \$1 million below the budget request.

- **Office of Management and Budget (OMB)** – The bill provides \$129 million, \$17 million below the budget request.
- **Office of National Drug Control Policy (ONDCP)** – The bill includes a total of \$456 million for ONDCP, \$2 million above the fiscal year 2025 level and \$435 million above the request. Including:
 - \$299 million for the **High Intensity Drug Trafficking Areas Program**, an increase of \$299 million above the request.

The Judiciary – The bill includes a total of \$9.2 billion for operations of the Judiciary, an increase of \$584 million above the fiscal year 2025 level and \$278 million above the House level.

- **Courts of Appeals, District Courts, and Other Judicial Services** – \$6.1 billion, an increase of \$132 million above fiscal year 2025 and \$58 million above the House level.
- **Defender Services** – \$1.8 billion, an increase of \$315 million above fiscal year 2025 and the same as the request, to support the right to counsel.
- **Court Security** – \$892 million, \$142 million above the fiscal year 2025 and the same as the request.

District of Columbia (D.C.) – The bill includes a total of \$875 million, a increase of \$12 million above fiscal year 2025 and \$52 million above the request. This provides:

- \$40 million for **D.C. Resident Tuition Support**, the same as fiscal year 2025 and the request.
- \$90 million for **Emergency Planning and Security Costs** in D.C., the same as fiscal year 2025 and \$60 million above the request.

Independent Agencies:

- **Consumer Product Safety Commission (CPSC)** – The bill funds the CPSC at \$151 million, the same as the fiscal year 2025 and \$9 million above the House level. Within the total, \$2.5 million is provided for Virginia Graeme Baker Pool Safety grants and \$2 million for grants for the Nicholas and Zachary Burt Memorial Carbon Monoxide Poisoning Prevention Act of 2024.
- **Election Assistance Commission (EAC)** – The bill provides \$45 million in funding for **Election Security Grants** to safeguard elections and democracy, \$30 million above fiscal year 2025 and \$45 million above the request.
 - \$24 million is included for EAC operating expenses, a decrease of \$7 million above the request.
- **Federal Communications Commission (FCC)** – The bill includes \$416 million for the FCC, \$26 million above fiscal year 2025.
- **General Services Administration (GSA)** – The bill includes \$9.7 billion in Federal Buildings Fund spending for GSA, \$379 million above fiscal year 2025. The total funding level includes:
 - \$166 million in funding for new construction,
 - \$934 million for the repair of Federal buildings.
- **National Archives and Records Administration (NARA)** – The bill provides a total of \$454 million for NARA, an increase of \$3 million above fiscal year 2025 and \$36 million above the request.
- **SEC, Salaries and Expenses** – The bill includes \$2.1 billion, the same as fiscal year 2025 and \$123 million above the House funding level.
- **Small Business Administration (SBA)** – The bill provides \$1 billion for SBA, an increase of \$383 million above the budget request and \$169 million above the House level. The bill includes \$330 million, an increase of \$13 million above fiscal year 2025 enacted and \$180 million above the request, for Entrepreneurial Development Programs.
