SUMMARY OF FISCAL YEAR 2026 BILL

National Security, Department of State, and Related Programs

The fiscal year 2026 National Security, Department of State, and Related Programs (NSRP) funding bill invests \$50 billion in United States global leadership and cooperation, \$3.8 billion above the fiscal year 2026 House bill, and \$19 billion, 61 percent, above President Trump's fiscal year 2026 request. While the bill is \$9.3 billion, or 16 percent, below the amount provided in the fiscal year 2025 continuing resolution, it provides \$5 billion, 10 percent, more than the Administration spent on international affairs last year.

This legislation:

- **Affirms United States world leadership** at the United Nations (UN) and other multilateral and international financial institutions by fully meeting our commitments to multilateral banks and funds to meet our full treaty dues.
- **Supports women globally by** protecting funding for bilateral family planning and the United Nations Population Fund (UNFPA) and maintaining programming for their economic and political participation around the world.
- **Facilitates American cooperation with international environmental initiatives** by removing riders that would have blocked U.S. engagement.
- **Maintains directives on international development programming**, such as education, water and sanitation, and agricultural capacity, that were targeted by the Administration.
- **Reins in the Trump Administration and reasserts congressional oversight** on the uses of funds by increasing requirements for transparency.

Bill Summary

Funds for Critical Agencies –

- \$9.4 billion to support the operation of our diplomatic presence overseas through the **Department of State's Diplomatic Programs**, an increase of \$789 million above the fiscal year 2026 budget request and \$392 million above the fiscal year 2026 House bill.

- \$6.8 billion through a new **National Security Investment Program (NSIP)** account that supports the activities previously funded under Development Assistance; Economic Support Fund; Assistance to Europe, Eurasia and Central Asia; Transition Initiatives; and Complex Crises Fund. This is an increase of \$3.9 billion above – or more than double – the fiscal year 2026 budget request for these activities.
- \$5.5 billion for humanitarian assistance, including through a new **International Humanitarian Assistance** account that supports the activities previously funded under International Disaster Assistance and Migration and Refugee Affairs. This is an increase of \$1.5 billion, or 37 percent, above the fiscal year 2026 budget request for these activities.
- \$643 million for the **United States Agency for Global Media**, which protects access to accurate and timely news for people internationally. This is \$490 million above the fiscal year 2026 budget request.
- \$410.5 million for **Peace Corps**
- \$830 million for the **Millennium Challenge Corporation**, \$606 million above the fiscal year 2026 budget request.
- \$998 million for the **Development Finance Corporation**'s administrative expenses and program accounts, \$180 million more than the fiscal year 2026 budget request.

Global Health –

- \$5.9 billion for global **HIV/AIDS**, \$3.0 billion above the fiscal year 2026 budget request.
 - This funding includes \$1.25 billion for the Global Fund.
- \$3.5 billion for programs to improve **maternal and child health and fight infectious diseases**, \$2.6 billion above the fiscal year 2026 budget request.
- Includes \$575 million for **bilateral family planning**.

Conservation and Environment Programs –

- \$274 million for **biodiversity conservation**.
- \$89 million for combatting **wildlife trafficking**.
- \$132 million for **land management and protection** programs.
- \$150 million for the **Global Environment Facility**, which the fiscal year 2026 budget request zeroed out.

Removes the prohibition in the House bill on funding for the **Green Climate Fund**, **Clean Technology Fund**, implementation of the **Paris Agreement**, and compensation for loss and damages attributed to climate change.

Critical Country and Regional Programs –

- **International Boundary and Water Commission**: \$158 million, \$43 million more than the fiscal year 2026 budget request.

- **Taiwan:** Provides \$300 million from the Foreign Military Financing Program to support loans and loan guarantees for Taiwan, \$200 million more than the fiscal year 2026 budget request.
- **Countering the People's Republic of China (PRC) Influence Fund:** \$400 million, same as the fiscal year 2025 enacted level.
- **Indo-Pacific:** \$1.8 billion to help counter the growing influence of the PRC in developing countries, including \$175 million for Pacific Islands countries specifically. This is the same as the fiscal year 2025 enacted level.
- **American First Opportunity Fund:** \$850 million for emerging priorities under congressional oversight, \$1.2 billion less than the fiscal year 2026 budget request. In contrast to the request, this funding requires congressional consultation and notification and is subject to all regular authorities and limitations.
- **Countering Russian Influence Fund:** \$300 million, same as the fiscal year 2025 enacted level.
- **Israel:** \$3.3 billion, in accordance with our MOU commitments.
- **Egypt:** \$1.5 billion, \$75 million over the fiscal year 2025 enacted level. Withholds certain funds until the government makes further progress on human rights and the rule of law.
- **Jordan:** \$2.1 billion, \$450 million over the fiscal year 2025 enacted level.

Other Priority Programs –

- **Democracy Programs:** \$2.2 billion, with an additional \$315 million for the **National Endowment for Democracy**.
- **Educational and Cultural Exchanges:** \$667 million, which is \$617 million above the fiscal year 2026 budget request.
- **Critical development sectors:** \$895 million for basic and higher education, \$720 million for food security and agricultural development, \$338 million for water and sanitation, and \$185 million for energy development and access.
- **Foreign Military Financing (FMF):** \$6.2 billion, which is \$1 billion more than the fiscal year 2026 budget request.
- **International Narcotics Control and Law Enforcement (INCLE):** \$1.4 billion, which is \$1.3 billion more than the fiscal year 2026 budget request.
- **International Financial Institutions:** \$1.5 billion, which is \$154 million above the fiscal year 2026 budget request and \$1.3 billion above the fiscal year 2026 House bill. This includes funding for the World Bank's International Development Association, the Asian Development Fund, the African Development Fund, the European Bank for Reconstruction and Development, and the International Fund for Agricultural Development.

- **International Organizations:** Funding to fully meet the U.S. annual treaty dues, including \$2.6 billion for Contributions to International Organizations and Contributions for International Peacekeeping Activities. This is \$2.4 billion above the fiscal year 2026 budget request and \$1.7 billion above the fiscal year 2026 House bill.
- **Natural disaster preparation and mitigation:** \$192 million, including for Pacific Islands countries and other high-risk areas.
